- Customer can ask for a refund if the art has not shipped. If the
 purchased artwork has been shipped, the customer may request a
 refund provided the customer pays to have the artwork shipped back to
 the artist address.
- Cash or eTRANSFER payments must be made within 48 hours of the purchase date of any artwork.
- Seller can cancel and refund any order at any time, provided the art has not been shipped.
- Customer may not use the artwork for any commercial work such as prints, cards, posters, or any other print medium.
- Customer may not use the artwork for any on-line activity such as websites, on-line stores, Instagram, or Facebook.
- The artist retains all rights to digital reproduction of the purchased artwork and may use the art in any commercial product such as cards, bookmarks, posters, prints etc..

TERMS OF SERVICE

LAST UPDATE: **MARCH 30-2025**. This contract applies to the artist further called Seller and person or institution further called Customer purchasing from Seller a work of art further called Product. By ordering Product from the Seller the Customer agrees to the following terms and conditions:

PAYMENTS

- 1. Customer agrees to pay the due amount upfront for any orders of value lower or equal to the selling price of the product plus any shipping and handling costs noted on the artwork listing
- 2. The customer agrees to pay the full cost of the product before the art is shipped by the artist.
- 3. It is the responsibility of the Customer to determine if the Product included framing, matting or other costs.
- 6. Customer agrees that Product will be delivered only to a Canadian Address and that all deliveries will be made by Canada Post.
- 7. Customer is obliged to bear any costs incurred by requested alternative delivery method, such as postal costs, material costs.
- 8. It is sole responsibility of Customer to propose delivery method which works for both parties. Seller cannot be held accountable for Customer's loss of access to the delivery method, loss of shipped Artwork, or any other obstacles outside responsibility of the Seller.
- 9. Customer agrees to pay the total amount specified in Product description including shipping costs.
- 10. It is the sole responsibility of Customer to bear any currency conversion costs, bank transfer fees, payment provider service fees and any other costs involved in transferring funds to the Seller.
